HANDLER NOMINATION PROCEDURE

DATE: July 14, 2023

TO: CALIFORNIA AVOCADO HANDLERS

Created in 1978, the California Avocado Commission (CAC) strives to enhance the premium positioning of California avocados through advertising, promotion and public relations, and engages in related industry activities. Representing nearly 2,000 avocado growers throughout California, CAC serves as the official information source for California avocados and the California avocado industry.

In October 2023, the Commission will conduct its regularly scheduled general election to fill available seats on CAC's Board of Directors. The Commission strives to be a diverse and inclusive organization and is committed to continually educating the Board and employees, while evaluating internal processes, programs and policies. CAC recognizes the inherent benefit to the California avocado industry by having a diverse group of individuals serve as Board Members and Alternates. To ensure that the Board reflects the diversity of the avocado industry, the Commission is actively seeking individuals of all race, gender, age, religion, and sexual orientation, as well as persons with disabilities, for positions on the Board. The enclosed Summary of Open Seats lists the seats that shall be filled in the 2023 CAC General Election. The Handlers elected to these seats shall serve a two-year term, ending on October 31, 2025.

The CAC Election Procedures provide that Handler candidates for Member or Alternate Member seats on the CAC Board may be nominated by a petition, signed by one eligible handler (aside from the handler organization the nominee represents). * A person nominated as a Handler shall certify that they have a financial interest in handling avocados for market either through ownership, employment or membership in a legal entity which is actively and directly engaged in the handling of avocados. Furthermore, to be eligible to serve in a Handler seat, the handler entity which the nominee represents must have handled no less than one percent (1%) of the total industry volume of avocados in the preceding marketing year. Nominated Handlers shall complete an Affidavit of Eligibility declaring their eligibility to serve on the CAC Board as a Handler representative, Disclosure of Affiliations form and Candidate Statement (optional, but recommended).

The Commission will conduct the 2023 General Election utilizing a ranked choice voting method. With this method, the ballots ask voters to cast their vote by ranking candidates in order of preference (1st choice, 2nd choice, etc.), with the candidate receiving the highest number of 1st choice votes offered their choice of the available seat(s). In election cycles where two seats are available, among the candidates remaining, the candidate with the highest combined total number of 1st and 2nd choice votes will be offered the second available seat.

2023 CAC GENERAL ELECTION HANDLER AFFIDAVIT OF ELIGIBILITY

The California Avocado Commission (CAC) Election Procedures provide that Handler candidates for Member or Alternate Member seats on the CAC Board will be nominated by a petition, signed by one eligible handler*. In addition, all Handler candidates must sign this affidavit of eligibility to serve, certifying that they meet the qualifications for nomination as outlined below.

*A handler already serving on the Commission may simply notify the CAC of his or her intention to run for re-election, without providing a signed nomination petition.

QUALIFICATIONS FOR NOMINATION

- 1. <u>Handler Eligibility</u> To be nominated and elected for a Handler seat on the CAC Board, a person must have a financial interest in handling avocados for market either through ownership, employment or membership in a legal entity which is actively and directly engaged in the handling of avocados. Furthermore, the handler entity that the nominee represents must have handled no less than one percent (1%) of the total industry volume of avocados in the preceding marketing year.
- 2. <u>Nomination Petition</u> Commission Election Procedures provide that Handler candidates for seats on the Commission shall be nominated through a *petition* with one (1) signature from another handler. A Handler already serving on the Commission may simply notify the Commission of his/her intention to run for re-election without providing a petition. A blank petition for Handlers is enclosed with this packet.

PROCEDURE FOR NOMINATION

The following **Handler Affidavit of Eligibility** bearing your statement of eligibility to serve must be returned to the Commission along with the completed **Handler Nomination Petition**. All Handler candidates must also complete and submit the **Disclosure of Affiliations** form and the **Candidate Statement**. **All completed forms must arrive at CAC no later than <u>August 28, 2023</u>. Names of candidates who are determined by the Commission to be eligible shall appear on the 2023 General Election Ballot.**

HANDLER AFFIDAVIT OF ELIGIBILITY

CALIFORNIA AVOCADO COMMISSION 2023 BOARD OF DIRECTORS ELECTION

The Annual CAC Board Election will be held in October 2023 for one Producer Member Seat and one Producer Alternate Member Seat in each of the five CAC districts. In addition, one Handler Member Seat and one Handler Alternate Member Seat are also open. All seats in the 2023 CAC Election are for two-year terms. The California Department of Food and Agriculture (CDFA) will announce the results of the 2023 Annual CAC Board Election and seat new Board Members at the CAC Board meeting on November 16, 2023.
