



# 2023 CAC GENERAL ELECTION

## PRODUCER NOMINATION PROCEDURE

**DATE:** July 14, 2023

**TO:** CALIFORNIA AVOCADO PRODUCERS

Created in 1978, the California Avocado Commission strives to enhance the premium positioning of California avocados through advertising, promotion and public relations, and engages in related industry activities. Representing nearly 2,000 avocado growers throughout California, CAC serves as the official information source for California avocados and the California avocado industry.

In October 2023, the Commission will conduct its regularly scheduled general election to fill available seats on CAC's Board of Directors. The Commission strives to be a diverse and inclusive organization and is committed to continually educating the Board and employees, while evaluating internal processes, programs and policies. CAC recognizes the inherent benefit to the California avocado industry by having a diverse group of individuals serve as Board Members and Alternates. To ensure that the Board reflects the diversity of the avocado industry, the Commission is actively seeking individuals of all race, gender, age, religion, and sexual orientation, as well as persons with disabilities, for positions on the Board. The enclosed Summary of Open Seats lists the seats that shall be filled in the 2023 CAC General Election. Elected individuals shall serve a two-year term, ending on October 31, 2025.

The CAC Election Procedures provide that Producer candidates for Member or Alternate Member seats on the CAC Board may be nominated by a petition, *signed by five eligible producers in the district in which the person is seeking election.* \* A person nominated as a Producer shall certify that they meet the definition of a "Producer" or "Grower", defined by CAC Law as "any person who is engaged within this state in the business of producing, or causing to be produced, avocados for market. "Producer" or "grower" does not include any person who has an average annual production of less than 10,000 pounds of avocados in the three preceding marketing years." Nominated Producers shall complete an Affidavit of Eligibility declaring their eligibility to serve on the CAC Board as a representative of the district in which their grove is located, Disclosure of Affiliations form and Candidate Statement. Please refer to the enclosed city and zip code list to determine the district in which your grove is located.

The Commission will conduct the 2023 General Election utilizing a ranked choice voting method. With this method, the ballots ask voters to cast their vote by ranking candidates in order of preference (1<sup>st</sup> choice, 2<sup>nd</sup> choice, etc.), with the candidate receiving the highest number of 1st choice votes offered their choice of the available seat(s). In election cycles where two seats are available, among the candidates remaining, the candidate with the highest combined total number of 1st and 2nd choice votes will be offered the second available seat.

## 2023 CAC GENERAL ELECTION PRODUCER AFFIDAVIT OF ELIGIBILITY

The California Avocado Commission Election Procedures provide that Producer candidates for Member or Alternate Member seats on the CAC Board may be nominated by a petition, *signed by five eligible producers in the district in which the person is seeking election\**. In addition, all Producer candidates must sign this affidavit of eligibility to serve, certifying that they meet the qualifications for nomination as outlined below.

*\*A producer already serving on the Commission may simply notify the Commission of his or her intention to run for re-election, in the same district, without providing a signed nomination petition.*

### QUALIFICATIONS FOR NOMINATION

1. Any person nominated as a Producer shall certify that they meet the definition of a “Producer” or “Grower”, defined by CAC Law as “any person who is engaged within this state in the business of producing, or causing to be produced, avocados for market. “Producer” or “grower” does not include any person who has an average annual production of less than 10,000 pounds of avocados in the three preceding marketing years.”
2. Any person nominated as a Producer shall certify that, under the same legal entity which qualifies him/her as a Producer, he/she is not a handler or an employee of a handler.
3. A person shall be nominated in *only one district*. Producers who produce avocados in more than one district must select one district in which they wish to be nominated.
4. All Producer candidates must meet the qualifications for nomination and submit a Disclosure of Affiliations Statement and any other documents required by the Commission. Any person elected to the Commission shall maintain his/her qualifications during the entire term of office.

### PROCEDURE FOR NOMINATION BY PETITION

The following **Producer Affidavit of Eligibility** bearing your statement of eligibility to serve must be returned to the Commission along with the **Producer Nomination Petition**, with the signatures of *five growers in the district* who endorse your nomination. All Producer candidates must also complete and submit the **Disclosure of Affiliations** form and **Candidate Statement**. **All completed forms must arrive at CAC no later than August 28, 2023**. Names of candidates who are determined by the Commission to be eligible shall appear on the 2023 General Election Ballot.

### PRODUCER AFFIDAVIT OF ELIGIBILITY

The Annual CAC Board Election will be held in October 2023 for one Producer Member Seat and one Producer Alternate Member Seat in each of the five CAC districts. In addition, one Handler Member Seat and one Handler Alternate Member Seat are also open. All seats in the 2023 CAC Election are for two-year terms. The California Department of Food and Agriculture (CDFA) will announce the results of the 2023 Annual CAC Board Election and seat new Board Members at the CAC Board meeting on November 16, 2023.
