#### ITEM #1 CALL TO ORDER

Ben Kardokus, representing the California Department of Food and Agriculture (CDFA), called the meeting to order at 9:01 a.m.

<u>Announcement of Election Results and Introduction of New Members and Alternates - Item 1.a.</u> Mr. Kardokus announced that results from the recently concluded 2022 CAC General Election had been tallied and the following individuals had been elected to the CAC Board for two-year terms ending October 31, 2024:

Mr. Kardokus reported that during the election 195 valid ballots had been received, with 29 ballots disqualified. He noted that the disqualified ballots had no impact on the results of the election.

#### Roll Call – Item 1.b.

Mr. Kardokus conducted roll call attendance and determined that a quorum was present.

#### Introductions

April Aymami, CAC industry affairs director, announced the United States Department of Agriculture (USDA), CDFA, CAC staff, CAC agency personnel and known guests participating in the meeting. She asked for all other guests to announce themselves and recorded all participants in attendance.

#### **ITEM # 2 OPPORTUNITY FOR PUBLIC COMMENT**

John Cornell, CAC District 2 Board Member, provided comments regarding Rob Grether and his possible nomination as CAC Chair for the 2022-23 term. He urged the Board not to support Mr. Grether's nomination, listing various reasons for his position. It was Mr. Cornell's opinion that Mr. Grether demonstrated unethical behavior and should have recused himself from voting on a CAC Public Member nominee due to his personal friendship with the individual. In addition, he felt that Mr. Grether should have advised the Board when he became aware that the previous CAC president had moved out of state. Lastly, Mr. Cornell noted that after coming to an agreement with Mr. Grether regarding his reimbursable travel expenses to attend the November CAC Board meeting, that Mr. Grether had later come back with a new interpretation of the CAC travel policy and unjustly reduced the amount Mr. Cornell could submit for reimbursement.

#### **ITEM # 3 ELECTION OF OFFICERS**

<u>Instruction on How Nominations and Voting for Board Officers will be Conducted – Item 3.a.</u> Mr. Kardokus provided a brief overview of Commission law and procedures as pertains to the nomination and election of Board officers.

Following the instructions on nominations and voting for board officers, Mr. Kardokus called for nominations for the seat of Chairperson. Rob Grether was nominated for the position of Chairperson by Rachael Laenen. Michael Perricone was nominated for the position of Chairperson by John Cornell. Subsequently, Mr. Perricone declined the nomination for the position. There were no further nominations for the position of Chairperson.

Mr. Grether assumed the position of Chairperson and requested nominations for the position of Vice-Chairperson. Rachael Laenen was nominated for the position of Vice-Chairperson by Jason Cole. There were no further nominations for the position of Vice-Chairperson.

#### **ITEM #6 OPERATIONS REPORT**

<u>Annual Audit - Item 6.a.</u>

Ken Melban, CAC vice president of industry affairs and operations, reported CAC management had issued a request for proposals for financial audit services, with responses due back by the end of November 2022, in hopes that the final audit report could be presented to the Board at the February 2023 meeting.

Mr. Melban also reported that CAC's internal control policies and procedures were currently under review and that the operations department was working to transition month-end accounting services to an outsourced accounting firm.

#### ITEM #7 CAC 2022-23 MARKETING BUSINESS PLAN REVIEW

Revised Budget - Item 7.a.

Consumer-Trade Overview 7.b

Jeff Oberman, CAC president, commented that at the October 2022 CAC meeting, the Board had taken action to approve an \$8.6 million dollar marketing budget with the direction to management to revise the marketing plan within defined parameters. He noted that the marketing team had incorporated the Board's directive into the plan presented in the Board packet.

Jan DeLyser, CAC vice president marketing, summarized the revisions, noting the percentage shift between consumer and trade activities, with consumer scaled back and an increase to trade. She went on to explain the importance of the integration between CAC marketing programs and the need to continue to support the consumer advertising program which helps pull fruit through the market. Ms. DeLyser recognized the Board's desire to dig deeper into the marketing programs and make adjustments, and encouraged them to approve the plan as presented, as the revisions made addressed the requests of the Board.

The Board and management discussed various details of the proposed plan, highlighting the need for CAC to own content and assets, and look for opportunities to bring projects in-house instead of using third-party content creators. There was a desire to better understand how the marketing dollars were being spent and develop metrics to gauge success and return on

investment. An explanation was provided about the monies allocated for export marketing, noting the nominal budget was only CAC's matching funds to support the larger overall budget which was funded through federal grants. It was noted that while not much California fruit had been exported in recent years, that the export marketing promotions help provide another avenue for handlers to move California fruit when the U.S. market may be saturated. There was concern raised about the number of small cuts made to many programs, and the result of the overall effectiveness of the programs, to which management felt the proposed budget and plan allowed California to keep a foot in the door with these programs on a small crop year. Lastly, the question of using agencies, versus in-house staff, was raised. Comments were made in support of both options, and it was noted that all organizations like CAC have to continually evaluate what is done in-house as opposed to outsourced. The discussion concluded with the understanding that it was the Board's duty to approve a budget and management's responsibility to determine the most effective way to allocate resources to execute the plan.

#### **ITEM #8 TRACKING STUDY PRESENTATION – TEMRA WALD**

Ms. DeLyser introduced Temra Wald of Temra Wald Consulting. She noted that Ms. Wald had worked on CAC's business for many years bringing unique expertise that helps CAC craft the study to continually improve results.

Ms. Wald presented the results of the 2022 CAC Tracking Research providing an overview of methodology used, along with highlights of significant findings. The research concluded that awareness of California continues to be strong and mostly associated with summer, followed by spring. While U.S. and locally grown continues to be important, it was noted that checking for region had declined. Additionally, California Avocados continued to be seen as most premium, best quality and best tasting, freshest, safest, worth paying more for and the preferred region. With regard to fruit size, large was still the preferred choice, but preference for small had increased. Lastly, sustainability continued to be important among consumers and worth paying more for.

As a result of these findings, Ms. Wald suggested CAC continue to communicate the benefits of being grown in California, continue to remind consumers why California Avocados are better and worth paying more for and reinforce the messages regarding the sustainable growing practices utilized by California growers.

During Board discussion a question was raised about how to get this information to the handlers, to which Ms. DeLyser stated the same presentation would be made to the CAC Marketing Committee and was incorporated into parts of the handler season kick-off meetings conducted by CAC in January. Another question was asked about health and nutrition and why CAC didn't focus on those areas in the tracking study. Ms. DeLyser noted that the Hass Avocado Board conducts a similar study each year and addresses the areas of health and nutrition.

#### **ITEM #9 INDUSTRY AFFAIRS REPORT**

Mr. Oberman reported on CAC management's meetings with industry stakeholders at the International Fresh Produce Association Global Produce & Floral Show. He noted that it was expected 2023 would see an large increase in avocado volume in the U.S. and the importance of maintaining relationships to support the growth of the U.S. market.

Mr. Melban stated that a virtual workshop to present information regarding the GEM variety was scheduled for December. He had invited handlers to participate in a panel discussion during the workshop to provide factual information about the variety and the marketing plans each handler had in place. A suggestion was made that the handlers should gather information from their retail partners about their position on other varieties to present at the meeting as well.

There was an open discussion about CAC focusing on marketing versus the sustainability of the California avocado industry. It was commented that CAC cannot ensure all growers or potential growers are profitable and that there are limited areas that CAC can impact, specifically work to drive volume and value higher. Points were made for increased grower education and outreach to improve production per acre, however even then, with production costs varying greatly across regions, it would be difficult to ensure increased profitability for all. It was also noted that many other handlers and grower associations were conducting extensive grower outreach and education seminars, many of which CAC supported or participated in.

Lastly, Mr. Melban provided a brief update on his work with a group to look at how to revitalize agriculture in San Diego County. The focus was on increasing productivity and improving efficiencies to sustain avocado growers. Once the work plans are finalized, the hope is that growers would be able to tap into grant funds for projects aligned with these goals.

#### **ADJOURN MEETING**

Mr. Grether adjourned the meeting at 11:35 a.m. The next regularly scheduled Board meeting will be held on February 28, 2023.

Appointments are subject to approval by the Commission and may be changed from time to time as determined by the Chairperson and concurred in by the Commission. (Article IV, 1.b).

In addition, the Bylaws allow the Chairperson to appoint committee members from among the Board members and alternates, as well as the industry in general. (Article IV, 1.d).

Chairman Rob Grether has acted in accordance with the above and appointed Chairpersons for several functional committees. Chairman Grether and the committee Chairpersons then conferred regarding committee members. The attached list has been prepared for Board approval.

# ITEM 3.d:CONSIDER APPROVAL OF CAC AS PROVIDER OF AVOCADO INSPECTIONPROGRAM ADMINISTRATIVE SERVICES FOR THE CDFA FOR THE PERIODFROM JULY 2023 THROUGH JUNE 2024

#### SUMMARY:

Each year a Memorandum of Understanding (MOU) must be renewed with the California Department of Food and Agriculture (CDFA) to allow CAC to continue as administrator of the Avocado Inspection Program (AIP). The AIP oversees avocado variety maturity standards, weight certification, uniformity of size, and ensures correct labeling of avocado cartons to conform with applicable regulations.

CAC staff handles the collection and disbursement of certification fees from California avocado handlers with oversight by the Avocado Inspection Committee (AIC). CAC also is responsible for retention of AIP personnel. Annual approval by the Board is required for CAC to continue administration of the funds. The item is scheduled for consideration early each fiscal year to allow time for the CDFA approval process.

#### FISCAL ANALYSIS:

CAC has provided this administration service for AIP since 1986, resulting in industry savings of approximately \$175,000 annually for a cumulative avocado industry savings of over six million dollars due to the minimization of state government overhead expenses. CAC is reimbursed by AIP for providing administrative services. In 2022-23, this amount will be \$61,000, of which \$50,300 is for personnel costs and \$10,700 is for liability insurance.

While CAC has solicited nominations for the District 1 producer alternate vacancy prior to the March Board meeting, nominations will also be accepted from the floor at the upcoming meeting. Note that nominees have the option to be present during the vote to fill the vacant seat and voting may <u>not</u> be conducted by secret ballot (Election Procedures, Section VII, C).



Over the years, I took a lot of pleasure in watching the development and growth of my parent's avocado ranch.

Following graduation from college and law school, I returned to the San Diego county area, and have been a practicing attorney for over 38 years. About fifteen years ago, I purchased my first avocado grove, and then in subsequent years, purchased five additional groves. I currently farm approximately 250 acres of avocados. Although I have about 100 acres of Haas trees, I have become actively involved in exploring high density plantings in both Reed and GEM avocados. I see the Reed and GEM varieties as offering a potential alternative to the financial challenges facing the California avocado community.



### ITEM 5.b: CONSIDER PUBLIC MEMBER SELECTION PROCESS

### SUMMARY:

In November, following CAC's submission of public member recommendations to the California Department of Food and Agriculture, the CDFA provided the following response:

"The California Department of Food and Agriculture (Department) is returning the nominees recommended by the Commission at their board meeting held on October 20, 2022. Sections 67051, (67052.5.(a)) of the Commission's Law state there shall be one public member (alternate public member) who shall be appointed by the secretary from nominees recommended by the commission.

The Department has received concerns about whether the nominees would suitably represent the public, and be fully independent participants in board decisions. Also, serious claims of bias were raised at the recent board meeting. The Department is cautious to act without further examination into the concerns and claims that have been raised.

We also consider that this process did not allow adequate time for the board's evaluation and decision. We suggest the board review the methods the staff uses in recruitment, candidate presentation and documentation requirements, and when to request actions from the board.

Therefore, we urge the Commission to reevaluate their process, and present recommendations to us at a future date."

In response to CDFA's feedback, CAC management notified the Board that staff would work on developing an improved process to address CDFA's concerns and would report back to the board. The attached "Public Member Selection Process" has been developed by management with guidance from Kahn, Soares and Conway, CAC's legal counsel. It was reviewed by the Executive Committee in January and their recommended edits have been incorporated and submitted to the Board here for approval.

### PUBLIC MEMBER SELECTION PROCESS

Commission law provides that the Commission Board of Directors shall recommend to the Secretary of Food and Agriculture the appointment of a public member and alternate public member to serve on the Board in accordance with Commission law.

The process to be utilized by the Commission for such action is as follows.

- 1. Solicit applications (with resumes) which demonstrate expertise in food safety, public health, nutrition, marketing, public education or other relevant experience. Preference for California residents.
- 2. The Executive Committee shall review the information provided by applicants and may interview applicants and/or require additional information to ensure that applicants are in compliance with Commission law and to evaluate each applicant's qualifications for the public member positions.
- 3. When the Executive Committee determines that one or more applicants are qualified, it shall recommend to the Board of Directors consideration of such applicants for available public member positions.
- 4. The Board of Directors shall interview each applicant recommended by the Executive Committee.
- 5. Upon completion of the process, the Board of Directors may schedule a meeting to consider recommending to the Secretary of Food and Agriculture the appointment of specific applicants to one or both public member positions.



### ITEM 6.b: CONSIDER RENEWAL OF LINE OF CREDIT

### SUMMARY:

Management prepares cash flow and ending reserves projections for each fiscal year based on CAC's historical cash flow pattern and several assumptions including volume and price per pound. Upon review of the 2021-22 reserves balance and the updated cash flow projection for 2022-23, management is not anticipating a need for the line of credit to be utilized during the 2022-23 fiscal year. However, to act prudently and be prepared for a worst-case situation (e.g. catastrophic crop failure), management recommends the renewal of CAC's line of credit in the amount \$3,000,000 (the same amount as in previous years).

Due to staffing changes at Bank of the West, at the time of this writing CAC management was unable to get the terms of line of credit renewal, however the existing terms are listed below:

- \$3,000,000 line of credit
- Interest rate is Prime Rate plus 0.5% with a floor of 4%
- No fees
- Maturity extended to May 31, 2023 (originally 2/28/23 but a 90-day extension was granted)

Because the next CAC Board meeting is not scheduled to take place until June, at this time CAC management is seeking approval from the Board to secure a line of credit in the amount of \$3,000,000 with final terms of the credit line approved by either the Finance or Executive Committee. This approval would be with the understanding that if Bank of the West does not offer favorable terms, CAC management and the designated Committee are authorized to seek out a lender with the most favorable terms.

### ITEM 6.c: PINE TREE RANCH LEASE RENEWAL

### SUMMARY:

On January 26, CAC Staff met with Cal Poly Pomona (CPP) representatives to discuss the renewal of the lease for Pine Tree Ranch, which is currently set to expire June 30, 2023. There were three key issues CAC wished to discuss with CPP: monthly rental rate, the installation of a variable frequency drive on the well for the property, and the involvement of CPP students in CAC projects.

Regarding the rental rate for Pine Tree Ranch, CAC's original lease started at a monthly rate of \$1,450 and increased approximately 3.5% annually to the current rate of \$1,976. Prior to meeting with CPP, CAC staff had discussed the rental rate with several area grove managers and owners and found general agreement that the lease rate was appropriate for the area. Thus, CAC staff told CPP that it was CAC's desire for the lease rate to remain at the current rate with an annual increase of 3.5%. CPP representatives agreed with this sentiment but indicated that the Cal Poly Pomona Foundation would require a current market assessment be conducted to determine if the current rental rate was appropriate.

The second issue CAC staff raised with CPP representatives was with respect to the installation of a variable frequency drive (VFD) on the primary well used for irrigation on the property. Two wells exist on the property, a smaller well on the portion of the property that CAC leases and a larger well on the CPP portion of the property. The original intention was for CAC to use the smaller well to irrigate our portion of the property. However, the quality of the water from this well is extremely poor and proved toxic to CAC's trees. Thus, since shortly after beginning the original lease in 2013, CAC has been sharing the larger well with CPP. This well has too much flow to irrigate CAC's portion of the ranch without either dumping excess water or also irrigating a portion of the rest of the ranch. A VFD would allow the well pump to be throttled and CAC to irrigate independent of the rest of the ranch. CPP representatives agreed that dumping water looks bad for the University and CAC and could lead to fines from the water district to the University. CPP representatives indicated that it had been quite some time since any capital investment had been made by the Foundation and they felt this would be a non-issue to get Foundation funding to pay for this upgrade.

The last issue CAC staff wished to discuss with CPP was a clause in the original lease to "support the mission of the University in its use of the Site, including... utilizing University students for internships and other opportunities to support the hands-on learning approach... or support the Foundation's efforts to renovate the residence at Pine Tree Ranch." To Staff's surprise, this clause was brought up by CPP prior to our doing so. CPP

acknowledged that the residence at Pine Tree Ranch may never be completed, and CAC urged the removal of that item from the lease clause. However, we agreed that CAC is still supportive of working with CPP to utilize students in any way possible going forward and we would agree to cooperate with CPP to have students participate in research projects or have students utilize trees on CAC's portion of the ranch for master's degree research if such opportunities were in our mutual interest.

The meeting concluded with the understanding that CPP representatives would conduct their market assessment regarding the rent rate and attempt to secure funds for the VFD. CAC staff are still waiting for an update from CPP.

### FISCAL ANALYSIS:

• The currently approved 2022-23 CAC Budget includes expenses for Pine Tree Ranch only through June 30, 2023. Once lease terms are finalized, CAC management will bring forward a budget amendment for the remainder of the 2022-23 fiscal year for Board approval.

### ITEM 10: CONSIDER APPROVAL OF HAB BOLD CANDIDATE SPONSORSHIP

### SUMMARY:

In 2021 the Hass Avocado Board launched the Hass Avocado Industry Board Leadership Program (BOLD) to develop emerging leaders interested in addressing the opportunities and challenges facing the Hass avocado industry. BOLD is designed to help participants improve profitability, increase the effectiveness of the industry and become board-ready candidates for HAB, the California Avocado Commission and importer associations. In January 2022, the Hass Avocado Board announced that applications for the second Board Leadership Development (BOLD) program were being accepted.

For the inaugural 2021 BOLD Class, the CAC Board had approved participation in and sponsorship of California applicants, with the caveat that they be an existing CAC Board member or alternate. After HAB received applications for the 2021 program, it was determined that two individuals met CAC's requirements and the Board approved sponsorship of Rachael Laenen and Connor Huser. Similarly, in 2022 CAC approved the sponsorship of District 3 Board Alternate Maureen Cottingham, having met requirements approved by the Board in 2021.

CAC management has been advised that while HAB received three California producer applicants during their call for 2023 BOLD participants, none of the applicants meet the criteria of being a CAC Board Member or Alternate. HAB has asked if the CAC is interested in supporting any of the California producers as 2023 BOLD participants, therefore CAC management is providing the applications submitted by the HAB BOLD applicants for CAC Board consideration.

### FISCAL ANALYSIS:

• The annual cost per participant is estimated to be up to \$9,000. The approved 2022-23 CAC Budget has \$18,000 allocated to cover the sponsorship of up to two participants.
