Criteria

In order to qualify for a new Ag Pass card, the agricultural operation that you are affiliated with must meet the following four criteria. Please confirm:

- 1. Any one agricultural operation may qualify for up to three (3) Ag Pass cards. To this point, your operation has been issued fewer than three cards. YES NO
- 2. Your agricultural operation is located within the State Responsibility Area (SRA) of Santa Barbara County. The SRA is recognized by the Board of Forestry and Fire Protection as areas where CalFire (or County Fire) is the primary emergency response area. Each ID card also requires a photo of the individual's head and shoulders, similar to a passport photo. We accept digital photos in .JPG format, not more than 500 KB in size. If you would prefer to be photographed by the Agricultural Commissioner's Office, you may arrange to make an appointment by calling (805)934-6200 or emailing mgraham@agcommissioner.com. Ag Commissioner staff will be available at trainings to take photos as well.

To complete your application and to receive your new Ag Pass card, you are required to participate in an Ag Pass training session. Trainings are four (4) hours in length, hosted by Santa Barbara County Fire Department, and occur 1-3 times annually. ***Please contact the Santa Barbara County Agricultural Commissioner's Office to learn when the next training will be offered.***
